
On behalf of the Board of Directors of Softball Ontario and its four provincial member associations, welcome to Softball Ontario's new strategic plan!

#### **Growing the Game**



## RGANIZATIONAL FFECTIVENESS



Align the operating systems of Softball Ontario and its Member Associations

- a. Create a standardized system of operational planning, budgeting and management reporting across all Member Associations and Softball Ontario, in line with Ontario Ministry of Sport requirements.
  - b. Move to consolidation of all member registration data across Softball Ontario's four Member Associations under one Softball Ontario-centralized data management platform.
    - i. Gather full registration data for all participants engaging in Softball Ontario sanctioned events anywhere in Ontario.

Establish a group marketing and communications function within Softball Ontario, serving all Softball Ontario Member Associations

a. Invest in the marketing capacity and expertise needed to drive these activities.

Enhance the documentation of operational processes within Softball Ontario

a. Review and expand Softball Ontario's HR manual, to include all policies and procedures with respect to staffing and volunteers at Softball Ontario.

Establish clarity of role and responsibility with regards to complaints and issues management in softball in Ontario

a. Clarify Softball Ontario's precise role here vis-à-vis its Member Associations, their affiliates, or higher levels of dispute resolution management.

# GROWING THE

Incentivize unsanctioned, unaffiliated softball leagues and/or teams (particularly at select level) to affiliate with Softball Ontario.

a. Implement policies that connect registered membership to the exclusive benefits of being affiliated with Softball Ontario.

b. Implement policies and rules that protect umpires and officials by encouraging them to officiate only Softball Ontario-sanctioned games and events.

Take a more proactive approach to 'telling our story', promoting the positive experiences people currently have participating in softball activities.


- a. Target special interest stories that support the execution of Softball Ontario strategies and activities/outcomes sponsored by Softball Ontario's funding agents.
  - b. Promote the success of Ontario softball athletes and teams at the national and international level.
  - c. Position softball as a generational activity, that people participate in from childhood through adulthood and into parenthood.

Provide greater support to Softball Ontario-affiliated clubs/leagues to help them grow the game.

a. Provide greater marketing and communications support to Member Associations and their clubs/leagues.

- b. Re-introduce the 'club in a box' development toolkit or develop a similar turnkey management kit for clubs to follow.
- Re-introduce the Softball Ontario Summit, to drive networking, peer-to-peer based club development initiatives and coach/umpire development clinics.
- d. Continue to drive the CanPitch program through affiliated clubs across Ontario.







Drive better opportunities for people to pursue coaching or umpiring careers in softball.

- a. Target players in late youth, teenage years to look beyond a playing career in softball.
- b. Provide better opportunities for females in coaching and umpiring, with clear pathways for them to develop.
- c. Foster the early development of existing coaches and umpires, minimizing early attrition rates.

Integrate Slo-Pitch Ontario's adult membership base more deeply into other softball activities in Member Associations.

- a. In particular, focus on coaching, umpiring and other volunteer activities and opportunities.
- b. Target the children of slo-pitch players to play, participate and remain in the Ontario softball family.

Target partnerships with local indigenous groups across Ontario to increase accessibility to softball for these groups.



- a. Build on existing partnerships and local activities within Softball Ontario's Member Associations.
- b. Explore alternate means of grant funding for these development activities, outside of the Ministry of Sport.

Provide the best opportunities for Ontario's top softball talent to be the best they can be.

a. Drive improved communication and partnership with Softball Canada with respect to vertical advanced performance development programs within Ontario.

b. Continue to provide excellence in the delivery of provincial competition and Ontario representation on Canadian national teams.

Enhance Softball Ontario's coaching support to its high-performance program.

a. Enhance the volume of coach facilitators in Ontario, to drive stronger capability in Softball Ontario's coach education program.

b. Move to establish minimum coaching standards at all levels of softball play, including necessary Safe Sport education for all.

Strengthen Softball Ontario high performance umpiring development, to complement a three-pronged approach (athlete, coach, umpire) in high performance development in the sport in Ontario.

a. Identify high level umpiring leadership across the province to manage the program.

b. Establish high performance umpiring talent identification, targeting Level 3-5 umpires, and bespoke development pathways for these individuals.

c. Align high performance initiatives closely with Softball Canada's national umpire development program.
